



25-YEAR LIMITED WARRANTY

PRIMED COMBED FASCIA, TRIM, SILL, AND COLUMN WRAP PRODUCTS

Limited Warranty

SilvaStar Forest Products warrants to the original purchaser and the first subsequent owner of the structure on which SilvaTrim Primed Fascia and Trim Products are installed that, when properly stored, installed, finished, and maintained, SilvaTrim products will remain free from manufacturing defects that result in rot, delamination, or excessive swelling for a period of twenty-five (25) years from the original date of purchase.

Should a covered defect occur during the warranty period, SilvaStar Forest Products, at its sole option, will repair the defective product, replace the defective product, or reimburse the reasonable replacement cost of the defective product, not to exceed two (2) times the original SilvaStar Forest Products sales price of the defective portion of the product.

These remedies are the Covered Person's sole and exclusive remedies under this warranty. This warranty applies only to products installed within the United States and Canada.

Warranty Conditions

This warranty applies only when SilvaTrim products are properly stored, handled, and installed; installed in accordance with SilvaStar installation instructions and applicable building codes; primed, painted, and maintained according to coating manufacturer recommendations; protected from prolonged moisture exposure; and used in normal residential or commercial construction applications. All field-cut ends, drilled holes, notches, routed areas, and exposed wood surfaces must be sealed during installation.

Warranty Claims

The Covered Person must notify SilvaStar Forest Products in writing within thirty (30) days after discovering a claimed defect. Proof of purchase and supporting documentation may be required. SilvaStar must be provided reasonable access to inspect the product before any repair, replacement, or alteration is performed. SilvaStar reserves the right to inspect, photograph, test, and remove samples of any product subject to a warranty claim.

Exclusions

This warranty does not cover damage or defects resulting from improper storage, handling, installation, finishing, maintenance, or use; failure to follow SilvaStar installation instructions or applicable building codes; ground contact, standing water, excessive moisture exposure, improper flashing, water intrusion, condensation, or building envelope failures; structural movement,

settlement, distortion, or failure of the supporting structure; neglect, abuse, misuse, vandalism, accident, impact damage, or product alteration; mold, mildew, fungi, algae, bacteria, insects, rodents, animals, or pests; fire, flood, hurricane, tornado, earthquake, lightning, hail, severe weather, or other acts of God; exposure to salt spray, chemicals, industrial fallout, pollutants, fertilizers, or corrosive substances; or normal weathering, fading, discoloration, chalking, paint deterioration, surface checking, or other cosmetic changes that do not affect structural performance.

This warranty does not cover the performance of paints, coatings, sealants, caulks, fasteners, flashing, or other materials not manufactured by SilvaStar.

Product Changes

SilvaStar Forest Products reserves the right to modify or discontinue any product without notice. If the original product is no longer available, SilvaStar may provide a comparable replacement product or reimbursement as permitted under this warranty.

Limitation of Liability

SilvaStar Forest Products shall not be liable for labor costs, removal costs, installation costs, freight charges, project delays, rental equipment, temporary housing, loss of use, loss of profits, damage to structures, damage to adjacent materials, damage to personal property, or any incidental, indirect, special, punitive, or consequential damages. In no event shall SilvaStar's total liability exceed the remedy expressly provided under this warranty.
